- Please send a copy of your FFL with Gun
 - If you are not a FFL holder, you must send a copy of your drivers license with gun. It must all be readable, with picture. If this is not included I will not transfer.
 - If you are not a FFL Dealer and you are sending a handgun, you cannot use the US Mail. It is illegal. You must use FedEx or UPS. If a gun is shipped to me illegally I will contact the ATF.
 - Send the gun in a way that it will need to be signed for. Otherwise it could sit in a unsecured area for several hours
 - Please note whom the gun is for.
